## **Doolgunna Project – Vulcan Exploration Update**

Enterprise Metals Limited ("Enterprise" or "the Company") (ASX: ENT) wishes to advise that the Moving Loop Electromagnetic (MLEM) survey over the Narracoota and Karalundi Formations at the Company's Vulcan-Goodins prospect commenced on 15<sup>th</sup> September and continued until 29<sup>th</sup> September, when the geophysical crew took a field break. The survey is due to recommence on 10<sup>th</sup> October 2015.

The geophysical contractor Vortex Geophysical Pty Ltd has completed approximately 26.4 line kilometres of the planned 103 line kilometre survey. (approx. 26%) Data has been acquired at 270 of 1,058 stations, with 788 stations (including infill) remaining. Based on the progress to date and an appraisal of the ease of access and density of vegetation for the remaining survey lines, the current schedule for the completion of the survey is around the first week in November, weather permitting.

Ongoing quality control is being monitored by the Company's geophysical consultants, Terra Resources Pty Ltd, to assess the level of external noise to the survey. Final survey data are anticipated to be delivered to the Company in early November, with processing, results assessment, interpretation and reporting planned for mid to late November.

## **Changes to Survey Specifications**




Figure 1. Location Plan showing Vulcan-Goodins Prospects over Greyscale magnetic image

The Company's consultants have altered the specifications of the survey from In-Loop configuration to Slingram configuration to reduce or eliminate IP effects seen in preliminary data. The transmitter frequency has also been increased from 0.125 Hz to 0.5Hz. Completed lines are shown in Figure 1 below.




Figure 2. Location Plan showing Vulcan-Goodins Prospects and Previous ENT Drill Results
