Chairman's Letter



Dear Shareholders,

During the year, the Company has generated and begun drill testing several copper-gold targets at Doolgunna, generated several nickel-copper targets in the Fraser Range, generated five highly prospective uranium projects and targets within or on the margins of the Yilgarn Craton in Western Australia, and prepared the groundwork for the drill testing of several large buried channel iron type targets in the Earaheedy Basin.

Of all these projects, Doolgunna is the most advanced, in that soil sampling by the Company at the Vulcan prospect has identified a copper anomalous zone over 1,500m by 500m, open to the northeast which is partly coincident with gold soil anomalism. Limited aircore drilling in the oxide zone has produced some highly anomalous gold results, but the primary zone, below 100m depth, remains untested. Anomalous Au, Cu, As, Bi, Mo, and Sb in soils and rockchips suggest a volcanogenic massive sulphide (VMS) style setting, similar to Sandfire Resources NL's nearby DeGrussa deposit.

A major 10,000m infill aircore drilling program is presently underway at Vulcan and the results of this program will allow us to target the primary zone with deeper RC drilling.

The other exciting development that has taken place during the year is the identification of five project areas with potential for substantial uranium resources. These projects, at Byro, Yalgoo, Peranbye, Ponton and Harris Lake are all located downstream from deeply weathered uranium rich source rocks. Airborne surveys by the Company have identified ancient river valleys (palaeochannels) likely to contain uranium, which have later been infilled with sand and clay.

It is Enterprise's view that Western Australia is well endowed with uranium, but lack of exploration incentive over the past 40 years has left the state largely underexplored for this commodity. Although the uranium price has been depressed for the past few years, the Company believes that the demand

for electricity in South East Asian countries, particularly China, and their plans to build nuclear power stations, will drive demand and the uranium price.

Given the specialised nature of uranium exploration and development, the Company has prepared plans for the demerger of its uranium assets into a separate company, Enterprise Uranium Ltd (ENU) via an in-specie distribution of ENU shares to Enterprise Shareholders, and subsequent ASX listing through an Initial Public Offering (IPO). The funds raised by the IPO will be used to drill test the numerous uranium targets that the Company has already identified.

The Company is now entering a crucial phase where drill testing of targets will be the dominant activity in 2012/2013. I thank you for the support that you have shown us so far, and encourage you to continue with us on this exciting journey of discovery.

introduction

Enterprise Metals Ltd (formerly Revere Mining Ltd or the Company) was incorporated in January 2007 as a public company for the purpose of acquiring Murchison Exploration Pty Ltd and its Revere Project gold tenements northeast of Meekatharra in Western Australia. The Company was admitted to the ASX on 20 June 2007.

In October 2008, the Company completed the acquisition of Enterprise Uranium Ltd and its portfolio of prospective iron ore, gold, uranium and base metal projects in Western Australia, and in December 2008, changed its name to Enterprise Metals Ltd (Enterprise).

in July 2011, SinoTech (Hong Kong) Corporation Limited ("SinoTech") took a strategic 30% stake in the Company, to assist it to drill test and develop its iron ore, gold, uranium and base metal targets.

Corporate Objective & Strategy

The Corporate Objective of the Enterprise Board continues to be "above average returns to Shareholders through successful multi-commodity exploration and the growth of the organisation into a major highly profitable mining company".

The key elements of the Company's strategy to achieve this objective are:


- the generation of a number of highly prospective multicommodity projects with potential for "Tier 1" resources,
- the application of best practice mineral exploration technology (with strong drilling and geophysics components) and
- the support of an experienced team of people with the appropriate technical, management and leadership skills, and a proven track record of discovery.

The Company's projects are largely within the Archaean Yilgarn Craton and surrounding Proterozoic basins and orogenic zones of Western Australia, where infrastructure is reasonably good compared to other more remote parts of Australia.

Enterprise believes there is still potential to find major new "Tier 1" (Worldclass) deposits in areas of shallow cover in Western Australia. The Company makes extensive use of airborne geophysics to "see through" shallow cover and identify conceptual geological targets.

The Company now holds approximately 12,300km² under exploration title.

Doolgunna Project

The Doolgunna Project covers 1,100km² and is located 110km northeast of Meekatharra and some 10km southwest of Sandfire Resources NL's DeGrussa Copper-Gold Mine, see Figure 1. The project is considered prospective for volcanogenic massive sulphide (VMS) and stratabound base metals and mesothermal stockwork gold.





Figure 2: Ironstone with Visible Gold

Recent exploration has focussed on the Vulcan Prospect, (12km southwest of the DeGrussa Copper-Gold Mine), where coarse visible gold was first identified in a shallow pit associated with an area of ferruginous laterite. The gold occurs within angular ferruginous fragments, some of which display "gossanous" textures, see Figure 2.

An estimated 500 tonnes of material was excavated from a costean and a total of 47 ounces of coarse gold recovered. This figure applies to the coarse "detectable" gold portion only, and does not take into account the presence of any "fine" gold.

Six follow-up aircore holes adjacent to and beneath the costean returned the following results:

DNAC069 3m @ 2.03 g/t Au from 1m 11m @ 0.58g/t Au from 92m DNAC132 2m @ 1.26g/t Au from 16m DNAC133 15m @ 2.03g/t Au from 35m Incl. 7m @ 3.66g/t Au from 42m 14m @ 1.01g/t Au from 54m

Soil sampling over the wider Vulcan area has defined a 1,500m long northeast trending zone of copper, with anomalous gold. A strong base metal multi-element association comprising gold, silver, arsenic, lead, zinc, molybdenum, antimony and cadmium was also identified on the open, eastern margin of Vulcan, see Figure 3.

Anomalous gold and copper results from a wide spaced aircore drilling program in the area surrounding Vulcan returned several anomalous results:

The Company also completed an RC drilling program in late 2011 over the Doolgunna, Ruby Well West and Ruby Well East prospects, which successfully tested coincident IP and elevated multi-element surface geochemical anomalies in Narracoota Formation volcanics.

At the Doolgunna Prospect, 10 RC holes were drilled confirming the presence of sulphide mineralisation at depth. RC drillhole DGRC007, drilled to test an IP anomaly in close proximity to the interpreted position of the Goodin Fault returned 8m @ 1.01% Cu, 1.6g/t Ag and 16.5 ppm Bi from 144m. The copper occurs as disseminated chalcocite hosted in fresh volcanics with associated quartz veining. DGRC007 is the first drill test of the prominent linear IP target located close to the Goodin Fault. Significant gold and copper results are summarised below.

DGRC003 4m @ 0.23 g/t Au from 52m

DGRC010 4m @ 0.40 g/t Au from 132m

DGRC004 85m @ 344 ppm Cu from 16m

DGRC005 138m @ 252 ppm Cu from 12m

DGRC007 8m @ 1.01% Cu from 144m

At the Ruby Well West and Ruby Well East Prospects, 21 shallow RC holes were drilled to test a number of coincident IP and elevated multi-element surface geochemical anomalies in Narracoota Formation volcanics and associated Karalundi Formation sediments. The RC drilling adequately explained the targeted IP features, with several holes returning narrow intervals of sulphide mineralisation with elevated gold and copper values.

Darlot Project

The Darlot Project covers an area of 895km² and is located about 40km east northeast of Leinster and lies approximately midway between the Bronzewing and Darlot gold mines in the Yandal Greenstone Belt. The project is considered prospective for high grade orogenic gold deposits and VMS style copper/zinc base metal deposits.




Figure 4: Darlot Project, Regional Geology

During the year, Enterprise completed a 14 hole RC drilling program and a 63 hole aircore drilling program at the Withers Find and Little Yanbo prospects, see Figure 4.

At Withers Find, a best interval of 7m @ 1.44 g/t Au from 108m in WFRC004 was received, however all drillholes returned narrow intersections with +1 g/t Au values, predominantly down dip or along strike of the known mineralisation.

At Little Yanbo, broad zones containing elevated gold values were also intersected, with LYRC001 returning an interval of 6m @ 2.33 g/t Au from 57m. This intersection occurred within the saprock/oxide portion of the profile and confirmed previous gold mineralisation. The RC drilling down dip of the known low grade mineralisation at both prospects failed to intersect higher grade mineralisation in the primary zone.

Fraser Range Project

The Fraser Range Project is located 60-100km east of the gold mining centre of Norseman in Western Australia and covers 596km². The Project is considered prospective for copper/nickel/Platinum Group Elements and gold mineralisation. The western most tenements are interpreted to overlie metamorphosed and sheared units of an Archaean greenstone belt. This area is interpreted to lie on or close to the contact between the Archaean Yilgarn Craton and the Mesoproterozoic Albany-Fraser Orogen and is a broadly similar tectonostratigraphic position to the 6.4 million ounce Tropicana gold deposit, some 300km to the northeast.




Figure 5: Fraser Range Project, Aeromagnetics

The central and easternmost tenements are interpreted to cover highly metamorphosed rocks of the Mesoproterozoic Albany-Fraser Orogen, which hosts Sirius Resources NL's recently announced "Nova" nickel discovery, see Figure 5.




Figure 6: Fraser Range Project, Ni-Cu-Co ("Nova-style") and Au Soil Anomalies

In 2011/2012, Enterprise completed regional calcrete and bulk soil sampling across the entire Fraser Range Project on a 400m x 800m pattern. Five areas with anomalous coincident Ni-Cu-Co geochemistry (similar metal association as "Nova") have been identified at the Plato, East Dam, EH1, EH2 and EH3 prospects, along with a gold target at Microwave, see Figure 6.

Infill soil sampling has been commissioned to further delineate the geochemical anomalies, which will be followed up with ground electrical geophysical surveys to define drill targets.

Wattagee Project




Figure 7: Wattagee Project, Regional Geology

The Wattagee Project covers an area of approximately 238km² and is located 30km north of Cue in the Murchison Province of the Yilgarn Craton, see Figure 7. The Company considers the project area to be prospective for gold deposits such as Big Bell and Cuddingwarra and VMS style base metal deposits similar to Golden Grove.

Previous drilling by Enterprise in early 2010 at Stockyard East returned a best result of 8m @ 5.8 g/t Au from 181m in RC hole STERC004, following up an intersection of 4m at 17.9 g/t Au. Three other holes testing IP features intersected massive or semi-massive sulphides (pyrite with lesser arsenopyrite) in fresh rock.

In 2012, two RC drillholes were completed at the Stockyard East Prospect, targeting the known mineralised structures identified in STERC004. The drilling returned a broad low grade intersection of 22m @ 1.07 g/t from 81m in STERC011, hosted by mafic volcanics containing disseminated sulphide with silicification and weak chloritisation.

Further assessment of these drill results and numerous soil geochemical anomalies is required.

Booylgoo Project

The Booylgoo Project is located 60km east northeast of Sandstone and covers the northern part of the Archaean Booylgoo Range greenstone belt and contains extensive mapped banded iron formation (BIF). The tenement is considered to have potential for iron ore.

Enterprise completed a detailed 100m line spaced airborne magnetic/radiometric survey over the project and undertook reconnaissance mapping and rockchip sampling. The high resolution magnetic survey more clearly defined the known BIF units and areas of demagnetisation which had potential to host high grade goethite and/or hematite. Approximately 28 strike km of multiple BIF units are apparent in the airborne data.

Systematic outcrop sampling (140 samples) of magnetic BIF on the eastern and western limbs of the syncline returned assays of between 25-40% Fe. However, 51 of the surface samples returned 50-65% Fe, with low silica ($\mathrm{SiO_2}$), alumina ($\mathrm{Al_2O_3}$) and phosphorous from outcrops of BIF enriched in iron by goethite alteration.

An RC drilling program of 30 holes was completed in July 2012. The drilling commonly intersected a ferruginous hard cap or ferricrete to 10-15m, underlain by an alternating sequence of BIF and felsic tuff, before grading into a mafic volcanic containing abundant magnetite. BIF was intersected beneath the iron rich surficial material (+50% Fe) in most holes, however limited iron enrichment was noted at depth, apart from several narrow 3-6m intervals. The BIF units are invariably siliceous and have an average downhole thickness of 20m. All iron rich intervals were analysed for an iron suite of elements by the XRF method and are summarised below.

Burracoppin Project




Figure 8: Burracoppin Project, Aeromagnetics

The Burracoppin Project covers an area of approximately 849km² and is located 280km east of Perth, straddling the Great Eastern Highway and the standard gauge railway line that runs from Kalgoorlie to the port of Kwinana, see Figure 8. The project is considered prospective for iron ore, gold, nickel and platinum group elements (PGE).

Enterprise drilled 31 RC holes to test a series of magnetic features with coincident elevated iron, gold or palladium (+platinum) assays in soil and rockchip sampling. The drilling returned several anomalous gold intersections (0.1-0.4 g/t Au) hosted within meta-basalts and dolerites, which are quartz veined, chlorite altered and contain minor sulphides. A number of holes with elevated gold, copper, arsenic and tungsten are of interest as this association also occurs at the 1.5 million ounce Edna May gold deposit, located approximately 20km to the northeast of the project.

A second program of 10 holes targeted gold mineralisation associated with the historic Burgess Find gold workings and a further six holes tested the iron ore potential of two linear aeromagnetic features at the Spring Well prospect.

The Burgess Find RC drilling targeted depth extensions to historic shallow high grade drilling results including: 4m @ 11.0 g/t Au from 13m, 3m @ 9.3 g/t Au from 32m, 5m @ 4.57 g/t Au from 38m. This mineralisation commonly occurs as oxide/supergene gold accumulations just above the base of weathering.

The 2012 drillholes intersected narrow, moderate to high grade gold in fresh rock below or down dip of the targeted oxide/supergene gold. All of the anomalous gold intersections are associated with chloritised intervals with varying amounts of quartz veining and disseminated pyrrhotite, and returned the following results:

The RC drilling at Spring Well intersected several narrow BIF units within "magnetic" mafic gneiss, explaining the magnetic features.

To date, the RC drilling targeting gold mineralisation has focussed only on the eastern margin of the large complex aeromagnetic feature in the centre of E70/3637. However, only 3km of the entire 15km eastern margin of the aeromagnetic feature has been tested, with further evaluation of this eastern margin and the western margin required.

Sylvania Project

The Sylvania Project covers 217km² and is located 50km southwest of Newman in the Pilbara region. The Project is considered to have potential for iron ore in the form of high grade bedded hematite, as well as detrital or channel iron deposits (CID).

Geological mapping, aeromagnetic interpretation and geochemical sampling over the project area resulted in the identification of both bedded hematite and palaeochannel iron drill targets. A 5,000m RC program has been designed to test these two types of target.

Government approvals for this drilling have been submitted, however negotiations regarding heritage and native title approvals have caused major delays during the year. A heritage clearance survey over the eastern portion of the project area was undertaken in October 2011, while a survey over the western portion has recently been completed in preparation for drilling.

Earaheedy Project

The Earaheedy Project covers approximately 1,057km² (619km² granted tenement) and is located 200km northeast of Wiluna and 800km northeast of Perth. The Project is considered to have potential for channel iron deposits (CID) and/or detrital iron deposits (DID) concealed beneath thin Cainozoic cover.




Figure 12: Earaheedy Project, Aeromagnetic Image Showing Channel Iron Targets

Enterprise originally image processed and interpreted Geological Survey of WA 400m line spaced airborne magnetic data over the project area identifying a series of major magnetic palaeochannels. These palaeochannels drain south from the banded iron formation (BIF) of the Lee Steere Ranges, along the northern margin of the Proterozoic Earaheedy Basin. Enterprise completed a detailed 100m line spaced (high resolution) aeromagnetic survey in November 2011, which confirmed the Company's interpretation, see Figure 12.

An orientation gravity survey identified gravity highs over two of the central magnetic palaeochannels, with geophysical modelling indicating that "discrete bodies" within the palaeochannels are possible sources for the observed gravity data. These interpreted palaeochannels are considered prospective for Channel Iron Deposits (CID) and/or Detrital Iron Deposits (DID), similar in setting and character to the Robe, Yandicoogina or Koodaideri deposits in the Hamersley Basin.

An RC drilling program comprising 139 holes along 14 traverses has been planned targeting the palaeochannels. Government approval has been received, however final heritage clearance is required prior to the commencement of drilling.

Byro Project

The Byro Project is approximately 250km northeast of Geraldton and has a combined area of 1,943km². The Project covers the Murchison River valley which is considered prospective for (blind) sand or sandstone hosted uranium mineralisation.




Figure 13: Byro Project, AEM over Topography

An airborne electromagnetic (AEM) survey was flown over the Wooleen Lake area in mid 2012 to identify deep palaeochannels with potential to host high grade uranium mineralisation. Six regional lines of AEM were also flown over selected areas of the Murchison valley, to test for deep sand hosted palaeochannels below previously identified calcrete outcrops with associated uranium anomalies, see Figure 13.




Figure 15: Exploration Licence 59/1617, AEM Conductivity Depth Image (CDI) Line 1001501.

Processing and interpretation of this data is currently underway and will be used to assist drillhole targeting. Preliminary results (Channel 15 depth slice and Conductivity Depth Images) indicate that buried palaeochannels up to 100m deep, underlie the modern drainage and are prospective for uranium, see Figure 15.

The Byro Radiation Management Plan was approved by the WA Radiological Council in July 2012. A "Radio Quiet Management Plan" (RQMP) to allow the Company to operate within the 70km restricted zone of the Square Kilometre Array (SKA) was also approved by the Department of Mines and Petroleum (DMP) and CSIRO.

Enterprise was successful in receiving WA Government cofunding of \$120,000 for RC drilling to test these uranium targets within the Wooleen region.

Yalgoo Project

The Yalgoo Project is approximately 400km north of Perth and covers an area of 1,253km². Enterprise considers the Project to be prospective for (blind) sand or sandstone hosted uranium mineralisation as well as calcrete hosted uranium.

In 2011/2012, the Company flew a large detailed 100m line spaced magnetic/radiometric survey over a portion of the Yalgoo Project area. All survey data from the 2010 and 2011 surveys was merged to provide a regional perspective of the Project's magnetic and radiometric character.

The merged data clearly identifies two drainage systems within the Project area containing elevated uranium, notably the 7.5km long Muggaburna channel, and the 30km long Salt Creek channel which runs in a north-south direction.




Figure 16: Muggaburna Prospect, Drillhole Locations over Uranium Image

A 115 hole aircore drilling program was completed in early 2012 over the Muggaburna prospect and over regional lines. At Muggaburna, 43 holes were drilled to test uraniferous surficial calcrete (up to 418 ppm in rockchip samples) and possible sand hosted uranium mineralisation associated with large palaeodrainage channels identified in the Company's airborne radiometric survey. The remaining holes were drilled in the wider region at 400-500m nominal spacing along station tracks, roads and fence lines, see Figure 16.

The drilling results are encouraging with nine holes yielding grade x thickness values over 200ppm*metres eU_3O_8 . The best grades identified to date are in two adjacent holes: YGAC083 and YGAC084 (100m apart) which yield 1.88m at 462ppm eU_3O_8 from 1.26m depth, and 2.16m at 457ppm eU_3O_8 from 1.17m depth respectively.

Most intercepts were shallow, between 0m and 4m vertically below surface, and the better intercepts were centred on the uraniferous calcrete exposure in the Muggaburna creek bed in a zone 200-450m wide, 900m long, and open to the north west and south east.

Holes were logged at 2cm intervals by calibrated wireline gamma probe. Equivalent eU_3O_8 values (denoted as eU_3O_8) were calculated by 3D Exploration Pty Ltd, assuming there is no disequilibrium*. Maximum downhole gamma logging results are given below.

* Note: Equilibrium is untested at Yalgoo, and actual uranium grades may vary significantly from those estimated if significant disequilibrium exists. The use of wireline probe data to estimate uranium grades is a standard industry practise, as it defines mineralised zones more precisely and is an acceptable grade estimation technique under the IORC Code.

Peranbye Project (Formerly Yalgoo South)

The Peranbye Project is located 300km north of Perth and covers an area of 1,625km². Tenements of the Peranbye Project were pegged following the identification of significant uranium anomalies in airborne radiometric data released in early 2012 by the Geological Survey of WA.

An initial field investigation of several of these uranium anomalies located highly anomalous concentrations of uranium mineralisation in calcareous clays and calcretes within lakes and palaeochannel systems.




Figure 18: Peranbye Project, Geology and Orientation AEM lines.

Assaying of surface rockchip and soil samples returned nine values between 102ppm U and 504ppm U, which confirms that significant surficial uranium mineralisation exists in the tenements, see Figure 18.

Reconnaissance sampling of untested areas and follow up and infill sampling of known anomalous areas will be undertaken as soon as field access is possible. This ground work will lead to the identification of targets for drill testing.

Twelve AEM lines were also flown over selected areas of the project to provide information on the depth of the palaeodrainage. Results will be used to assist planning of reconnaissance drillholes.




Figure 19: Peranbye E70/4295, E59/1857-1858, Orientation AEM Traverses over Uranium (red) and DTM.




Figure 20: Peranbye E59/4295, AEM Conductivity Depth Image

Ponton Project




Figure 22. AEM Defined Palaeochannels on DTM Image

The Ponton Project is located 135km east of Kalgoorlie and covers a total area of 1,240km² over the confluence of Lake Rebecca, Lake Yindana and the Ponton River on the southeast margin of the Archaean Yilgarn Craton.

in mid 2012, Enterprise flew a 1,000m line spaced AEM survey over the Project area, on the assumption that palaeodrainage systems within Enterprise's tenements were similar to those at the nearby Double 8 and Mulga Rocks projects, and that AEM could be used to map channels which have the potential to host uranium mineralisation, see Figure 22.




Figure 23: Ponton Project, Lake Rebecca, Sample of Conductivity Depth Images.

Samples of several Conductivity Depth Images from the AEM data on the northwest corner of E28/2206 are shown in Figure 23. The deepest channels are approximately 150m deep, and are targeted for RC drill testing.

Harris Lake Project

The Harris Lake Project is located 200km east of Kalgoorlie and covers an area 76.3km².

In 2011, the Company flew a detailed aeromagnetic and radiometric survey over the entire project area. The radiometric data acquired shows a highly anomalous uranium response on the Harris Lake drainage system.

In July 2012, the Company flew an AEM survey on 400m spaced lines over the project area in order to detect and define palaeochannels which may contain substantial sand hosted uranium mineralisation. This survey has defined deep channels favourable for the deposition of uranium mineralisation below and adjacent to Harris Lake.




Figure 26: Harris Lake Project, Sample Conductivity Depth Images from Northern Area

Shown below in Figures 25 and 26 are sample Conductivity Depth Images from the AEM survey, highlighting +150m

deep palaeochannels which Enterprise considers to be highly prospective for sand hosted uranium mineralisation.

The project area is within the proposed Harris Lake Nature Reserve, and is managed by the Department of Conservation (DEC). Enterprise has consulted with both the DMP and DEC and established protocols for a Conservation Management Plan (CMP).

The Harris Lake Radiation Management Plan has been approved by the WA Radiological Council, and drill testing of the deep channels is expected to commence in 2013.

The Board of Directors

The Company's constitution provides that the number of directors shall not be less than three and not more than nine.

As and if the Company's activities increase in size, nature and scope the size of the board will be reviewed periodically, and as circumstances demand. The optimum number of directors required to supervise adequately the Company's constitution will be determined within the limitations imposed by the constitution.

In order to ensure the board maintains an optimal mix of skills and diversity, the membership of the board, its activities and composition, is subject to periodic review. The criteria for determining the identification and appointment of a suitable candidate for the board shall include quality of the individual, background of experience and achievement, compatibility with other board members, credibility within the Company's scope of activities, intellectual ability to contribute to board's duties and physical ability to undertake board's duties and responsibilities.

Directors are initially appointed by the full board subject to election by shareholders at the next general meeting. Under the Company's constitution the tenure of a director (other than managing director, and only one managing director where the position is jointly held) is subject to reappointment by shareholders not later than the third anniversary following his or her last appointment. Subject to the requirements of the *Corporations Act 2001*, the board does not subscribe to the principle of retirement age and there is no maximum period of service as a director. A managing director may be appointed for any period and on any terms the directors think fit and, subject to the terms of any agreement entered into, may revoke any appointment.

The board has established Audit & Risk and Remuneration & Nomination committees. The board as a whole is committed to addressing the governance aspects of the full scope of the Company's activities and to ensure that it adheres to appropriate ethical standards.

Role of the Board

The board's primary role is the protection and enhancement of long-term shareholder value.

To fulfil this role, the board is responsible for oversight of management and the overall corporate governance of the Company including its strategic direction, establishing goals for management and monitoring the achievement of these goals.

Appointments to Other Boards

Directors are required to take into consideration any potential conflicts of interest when accepting appointments to other boards.

Independent Professional Advice

The board has determined that individual directors have the right in connection with their duties and responsibilities as directors, to seek independent professional advice at the Company's expense. With the exception of expenses for legal advice in relation to director's rights and duties, the engagement of an outside adviser is subject to prior approval of the Chairman and this will not be withheld unreasonably.

Continuous Review of Corporate Governance

Directors consider, on an ongoing basis, how management information is presented to them and whether such information is sufficient to enable them to discharge their duties as directors of the Company. Such information must be sufficient to enable the directors to determine appropriate operating and financial strategies from time to time in light of changing circumstances and economic conditions. The directors recognise that mining exploration is an inherently risky business and that operational strategies adopted should, notwithstanding, be directed towards improving or maintaining the net worth of the Company.

The principal activities of the Group during the financial year were the exploration of a number of gold, uranium and iron ore tenements in Western Australia.

Significant Changes in State of Affairs

On 23 May 2011, the Company announced that it had executed a Subscription Agreement for a private placement regulated by section 708 of the Corporations Act, with SinoTech (Hong Kong) Corporation Limited ("SinoTech") for 62 million ENT shares at an issue price of 20 cents each, to raise \$12.4 million for ongoing exploration. SinoTech was also offered 20,000,000 options at an exercise price of 25 cents each exercisable within two years of the date of grant. If 10,000,000 of these options are exercised by SinoTech within 1 year of their date of grant, then Enterprise will issue to SinoTech a further 11,000,000 options at an exercise price of A\$0.25, each exercisable within two years. On 13 July 2011, the Company announced that the Subscription Agreement had completed, and \$12.4 million of funds had been received from SinoTech. The Company issued 62 million shares at an issue price of 20 cents each and 20,000,000 options at an exercise price of 25 cents each exercisable within two years of the date of grant.

On 23 May 2011, the Company also announced that it had executed an Underwriting Agreement to the placement referred to above, with Worldtex Capital Resources Ltd ("Worldtex"). Enterprise agreed to pay Worldtex an underwriting fee of \$248,000 cash (representing 2% of the funds raised by the SinoTech Placement), and 15,000,000 Attaching Options. On 13 July 2011, the Company announced that the Underwriting Agreement had completed, and the underwriting fee of \$248,000 cash was paid and the 15,000,000 Options with an exercise date of 1 June 2013 were issued.

A. Remuneration Policy

The remuneration policy of Enterprise Metals Limited has been designed to align director and executive objectives with shareholder and business objectives by providing a fixed remuneration component, and offering specific long-term incentives based on key performance areas affecting the Group's financial results. The Board of Enterprise Metals Limited believes the remuneration policy to be appropriate and effective in its ability to attract and retain the best management and directors to run and manage the Group, as well as create goal congruence between directors, executives and shareholders.

Fees for non-executive Directors are not linked to the performance of the Group. However, to align Directors' interests with shareholder interests, the Directors are encouraged to hold shares in the Company.

The remuneration policy has been tailored to increase the direct positive relationship between shareholders' investment objectives and Directors' and executives' performance. Currently, this is facilitated through the issue of options to the majority of Directors and executives to encourage the alignment of personal and shareholder interests. The Company believes this policy will be effective in increasing shareholder wealth. NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

The financial report includes the consolidated financial statements and notes of Enterprise Metals Limited and controlled entities ('Consolidated Group' or 'Group'). Enterprise Metals Limited is a listed public company, incorporated and domiciled in Australia.

Basis of Preparation

These general purpose financial statements have been prepared in accordance with Australian Accounting Standards and Interpretations issued by the Australian Accounting Standards Board and the *Corporations Act 2001*. Enterprise Mining Limited is a for-profit entity for the purpose of preparing the financial statements.

Australian Accounting Standards set out accounting policies that the AASB has concluded would result in a financial report containing relevant and reliable information about transactions, events and conditions to which they apply. Compliance with Australian Accounting Standards ensures that the financial statements and notes also comply with International Financial Reporting Standards. Material accounting policies adopted in the preparation of this financial report are presented below. They have been consistently applied unless otherwise stated.

The financial report has been prepared on an accruals basis and is based on historical costs, modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and financial liabilities.

The financial statements were authorised for issue by the directors on 27 September 2012. The directors have the power to amend and reissue the financial statements.

(a) Principles of Consolidation

The consolidated financial statements incorporate the assets, liabilities and results of entities controlled by Enterprise Metals Limited at the end of the reporting period. A controlled entity is any entity over which Enterprise Metals Limited has the power to govern the financial and operating policies so as to obtain benefits from the entity's activities. Control will generally exist when the parent owns, directly or indirectly through subsidiaries, more than half of the voting power of an entity. In assessing the power to govern, the existence and effect of holdings of actual and potential voting rights are also considered.

Where controlled entities have entered or left the Group during the year, the financial performance of those entities are included only for the period of the year that they were controlled.

A list of controlled entities is contained in Note 12 to the financial statements.

In preparing the consolidated financial statements, all inter-group balances and transactions between entities in the consolidated group have been eliminated on consolidation. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with those adopted by the parent entity.

Business Combinations

Business combinations occur where an acquirer obtains control over one or more businesses and results in the consolidation of its assets and liabilities.

A business combination is accounted for by applying the acquisition method, unless it is a combination involving entities or businesses under common control. The acquisition method requires that for each business combination one of the combining entities must be identified as the acquirer (ie parent entity). The business combination will be accounted for as at the acquisition date, which is the date that control over the acquiree is obtained by the parent entity. At this date, the parent shall recognise, in the consolidated accounts, and subject to certain limited exceptions, the fair value of the identifiable assets acquired and liabilities assumed. In addition, contingent liabilities of the acquiree will be recognised where a present obligation has been incurred and its fair value can be reliably measured.

The acquisition may result in the recognition of goodwill or a gain from a bargain purchase. The method adopted for the measurement of goodwill will impact on the measurement of any non-controlling interest to be recognised in the acquiree where less than 100% ownership interest is held in the acquiree.

The acquisition date fair value of the consideration transferred for a business combination plus the acquisition date fair value of any previously held equity interest shall form the cost of the investment in the separate financial statements. Consideration may comprise the sum of the assets transferred by the acquirer, liabilities incurred by the acquirer to the former owners of the acquiree and the equity interests issued by the acquirer.

NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES (Cont'd)

Fair value uplifts in the value of pre-existing equity holdings are taken to the statement of comprehensive income. Where changes in the value of such equity holdings had previously been recognised in other comprehensive income, such amounts are recycled to profit or loss.

Included in the measurement of consideration transferred is any asset or liability resulting from a contingent consideration arrangement. Any obligation incurred relating to contingent consideration is classified as either a financial liability or equity instrument, depending upon the nature of the arrangement. Rights to refunds of consideration previously paid are recognised as a receivable. Subsequent to initial recognition, contingent consideration classified as equity is not remeasured and its subsequent settlement is accounted for within equity. Contingent consideration classified as an asset or a liability is remeasured each reporting period to fair value through the statement of comprehensive income unless the change in value can be identified as existing at acquisition date.

All transaction costs incurred in relation to the business combination are expensed to the statement of comprehensive income

Income Tax

The income tax expense (revenue) for the year comprises current income tax expense (income) and deferred tax expense (income).

Current income tax expense charged to the profit or loss is the tax payable on taxable income calculated using applicable income tax rates enacted, or substantially enacted, as at the end of the reporting period. Current tax liabilities (assets) are therefore measured at the amounts expected to be paid to (recovered from) the relevant taxation authority.

Deferred income tax expense reflects movements in deferred tax asset and deferred tax liability balances during the year as well unused tax losses.

Current and deferred income tax expense (income) is charged or credited directly to equity instead of the profit or loss when the tax relates to items that are credited or charged directly to equity.

Deferred tax assets and liabilities are ascertained based on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the financial statements. Deferred tax assets also result where amounts have been fully expensed but future tax deductions are available. No deferred income tax will be recognised from the initial recognition of an asset or liability, excluding a business combination, where there is no effect on accounting or taxable profit or loss.

Deferred tax assets and liabilities are calculated at the tax rates that are expected to apply to the period when the asset is realised or the liability is settled, based on tax rates enacted or substantively enacted at the end of the reporting period. Their measurement also reflects the manner in which management expects to recover or settle the carrying amount of the related asset or liability.

Deferred tax assets relating to temporary differences and unused tax losses are recognised only to the extent that it is probable that future taxable profit will be available against which the benefits of the deferred tax asset can be utilised.

Where temporary differences exist in relation to investments in subsidiaries, branches, associates, and joint ventures, deferred tax assets and liabilities are not recognised where the timing of the reversal of the temporary difference can be controlled and it is not probable that the reversal will occur in the foreseeable future.

Current tax assets and liabilities are offset where a legally enforceable right of set-off exists and it is intended that net settlement or simultaneous realisation and settlement of the respective asset and liability will occur. Deferred tax assets and liabilities are offset where a legally enforceable right of set-off exists, the deferred tax assets and liabilities relate to income taxes levied by the same taxation authority on either the same taxable entity or different taxable entities where it is intended that net settlement or simultaneous realisation and settlement of the respective asset and liability will occur in future periods in which significant amounts of deferred tax assets or liabilities are expected to be recovered or settled.

(c) Property, Plant, and Equipment

Each class of property, plant, and equipment is carried at cost or fair value less, where applicable, any accumulated depreciation and impairment losses.

Plant and equipment are measured on the historical cost basis.

The cost of fixed assets constructed within the Group includes the cost of materials, direct labour, borrowing costs, and an appropriate proportion of fixed and variable overheads.

Depreciation

The depreciable amount of all fixed assets is depreciated on a straight-line basis over their useful lives to the Group commencing from the time the asset is held ready for use.

The depreciation rates used for each class of depreciable assets are:

Plant and equipment	25%
Computers	33%

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at each reporting date.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains and losses are included in the statement of comprehensive income. When revalued assets are sold, amounts included in the revaluation reserve relating to that asset are transferred to retained earnings.

(d) Exploration and Evaluation Expenditure

Exploration and evaluation expenditure incurred is accumulated in respect of each identifiable area of interest. These costs are only carried forward to the extent that they are expected to be recouped through the successful development of the area or where activities in the area have not yet reached a stage that permits reasonable assessment of the existence of economically recoverable reserves.

Accumulated costs in relation to an abandoned area are written off in full against profit in the year in which the decision to abandon the area is made.

When production commences, the accumulated costs for the relevant area of interest are amortised over the life of the area according to the rate of depletion of the economically recoverable reserves.

A regular review is undertaken of each area of interest to determine the appropriateness of continuing to carry forward costs in relation to that area of interest.

(e) Leases

Leases of fixed assets where substantially all the risks and benefits incidental to the ownership of the asset, but not the legal ownership that are transferred to entities in the Group are classified as finance leases.

Finance leases are capitalised by recording an asset and a liability at the lower of the amounts equal to the fair value of the leased property or the present value of the minimum lease payments, including any guaranteed residual values. Lease payments are allocated between the reduction of the lease liability and the lease interest expense for the period.

Leased assets are depreciated on a straight-line basis over their estimated useful lives where it is likely that the Group will obtain ownership of the asset or over the term of the lease.

Lease payments for operating leases, where substantially all the risks and benefits remain with the lessor, are charged as expenses in the periods in which they are incurred.

(f) Financial Instruments

Financial assets and financial liabilities are recognised when the entity becomes a party to the contractual provisions to the instrument. For financial assets, this is equivalent to the date that the company commits itself to either the purchase or sale of the asset (ie trade date accounting is adopted).

Financial instruments are initially measured at fair value plus transaction costs, except where the instrument is classified 'at fair value through profit or loss', in which case transaction costs are expensed to profit or loss immediately.

The Group does not designate any interests in subsidiaries, associates or joint venture entities as being subject to the requirements of accounting standards specifically applicable to financial instruments.

Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market and are subsequently measured at amortised cost.

Loans and receivables are included in current assets, except for those which are not expected to mature within 12 months after the end of the reporting period. (All other loans and receivables are classified as non-current assets.)

Financial liabilities

Non-derivative financial liabilities (excluding financial quarantees) are subsequently measured at amortised cost.

Derivative instruments

Derivative instruments are measured at fair value. Gains and losses arising from changes in fair value are taken to the statement of comprehensive income unless they are designated as hedges.

Fair value

Fair value is determined based on current bid prices for all quoted investments. Valuation techniques are applied to determine the fair value for all unlisted securities, including recent arm's length transactions, reference to similar instruments and option pricing models.

Impairment

At each reporting date, the Group assesses whether there is objective evidence that a financial instrument has been impaired. In the case of available-for sale financial instruments, a significant and prolonged decline in the value of the instrument is considered to determine whether an impairment has arisen. Impairment losses are recognised in the statement of comprehensive income.

Derecognition

Financial assets are derecognised where the contractual rights to cash flow expires or the asset is transferred to another party whereby the entity no longer has any significant continuing involvement in the risks and benefits associated with the asset. Financial liabilities are derecognised where the related obligations are either discharged, cancelled or expired. The difference between the carrying value of the financial liability extinguished or transferred to another party and the fair value of consideration paid, including the transfer of non-cash assets or liabilities assumed, is recognised in profit or loss.

Impairment of Non-Financial Assets

At each the end of each reporting period, the Group assesses whether there is any indication that an asset may be impaired. The assessment will include the consideration of external and internal sources of information including dividends received from subsidiaries, associates or jointly controlled entities deemed to be out of pre-acquisition profits. If such an indication exists, an impairment test is carried out on the asset by comparing the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is expensed to the statement of comprehensive income.

Where it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the cash-generating unit to which the asset belongs.

Impairment testing is performed annually for goodwill and intangible assets with indefinite lives.

NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES (Cont'd)

(h) Employee Benefits

Provision is made for the Group's liability for employee benefits arising from services rendered by employees to reporting date. Employee benefits that are expected to be settled within one year have been measured at the amounts expected to be paid when the liability is settled, plus related on-costs. Employee benefits payable later than one year have been measured at the present value of the estimated future cash outflows to be made for those benefits.

Equity-settled compensation

The Group operates an Incentive Option Scheme share-based compensation plan. The bonus element over the exercise price of the employee services rendered in exchange for the grant of shares and options is recognised as an expense in the statement of comprehensive income. The total amount to be expensed over the vesting period is determined by reference to the fair value of the shares of the options granted.

(i) Provisions

Provisions are recognised when the Group has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will results and that outflow can be reliably measured.

(j) Cash and cash equivalents

Cash and cash equivalents includes cash on hand, deposits held at call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within short-term borrowings in current liabilities on the statement of financial position.

(k) Revenue and Other Income

Interest revenue is recognised on a proportional basis taking into account the interest rates applicable to the financial assets.

Rental income is recognised on an accrual basis.

Management fees are recognised on portion of completion basis.

All revenue is stated net of the amount of goods and services tax (GST).

(I) Trade and Other Payables

Trade and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the Group during the reporting period which remains unpaid. The balance is recognised as a current liability with the amount being normally paid within 30 days of recognition of the liability.

(m) Borrowing Costs

AUO BSM IBUOSIBO LO-

Borrowing costs directly attributable to the acquisition, construction or production of assets that necessarily take a substantial period of time to prepare for their intended use or sale, are added to the cost of those assets, until such time as the assets are substantially ready for their intended use or sale.

All other borrowing costs are recognised in income in the period in which they are incurred.

(n) Goods and Services Tax (GST)

Revenues, expenses, and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Tax Office. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the statement of financial position are shown inclusive of GST.

Cash flows are presented in the statement of cash flows on a gross basis, except for the GST component of financing activities, which are disclosed as operating cash flow.

(o) Government Grants

Government grants are recognised at fair value where there is reasonable assurance that the grant will be received and all grant conditions will be met. Grants relating to expense items are recognised as income over the periods necessary to match the grant to the costs they are compensating. Grants relating to assets are credited to deferred income at fair value and are credited to income over the expected useful life of the asset on a straight-line basis.

(p) Earnings Per Share

i. Basic earnings per share

Basic earnings per share is determined by dividing the profit attributable to equity holders of the company, excluding any costs of service equity other than ordinary shares, by the weighted average number of ordinary shares outstanding during the financial year, adjusted for bonus elements in ordinary shares issued during the year.

ii. Diluted earnings per share

Diluted earnings per share adjusts the figure used in the determination of basic earnings per share to take into account the after income tax effect of interest and other financial costs associated with dilutive potential ordinary shares and the weighted average number of shares assumed to have been issued for no consideration in relation to dilutive potential ordinary shares.

Comparative Figures

When required by Accounting Standards, comparative figures have been adjusted to conform to changes in presentation for the current financial year.

When the Group applies an accounting policy retrospectively, makes a retrospective restatement or reclassifies items in its financial statements, a statement of financial position as at the beginning of the earliest comparative period will be disclosed.

Critical Accounting Estimates and Judgments

The directors evaluate estimates and judgments incorporated into the financial report based on historical knowledge and best available current information. Estimates assume a reasonable expectation of future events and are based on current trends and economic data, obtained both externally and within the Group.

Key Estimates — Impairment

The Group assesses impairment at each reporting date by evaluating conditions specific to the consolidated entity that may lead to impairment of assets. Where an impairment trigger exists, the recoverable amount of the asset is determined.

The Directors considered the impairment of the parent entity's investment in subsidiaries and loans receivable from subsidiaries based on the fair value less costs to sell of the underlying mineral tenements. The inter-company loans have no interest or repayment terms and are effectively investments in controlled entities and are reflected at cost.

No impairment has been recorded for the year.

Key Estimates - Share based payment transactions

The Group measures the cost of equity-settled transactions with employees by reference to the fair value of the equity instruments at the date at which they are granted. The fair value is determined by using the Black-Scholes formula. Details of the estimates used to determine the fair value are detailed in Note 17.

Key Judgments - Exploration and Evaluation Expenditure

The Group capitalises expenditure relating to exploration and evaluation where it is considered likely to be recoverable or where the activities have not reached a stage which permits a reasonable assessment of the existence of reserves. While there are certain areas of interest from which no reserves have been extracted, the Directors are of the continued belief that such expenditure should not be written off since feasibility studies in such areas have not yet concluded. Such capitalised expenditure is carried at the end of the reporting period at \$21,249,099 (2011: \$16,597,534). An impairment of \$1,007,701 (2011: \$2,653,308) was recognised during the year ended 30 June 2012.

Key Judgments - Carbon Tax

On 10 July 2011, the Commonwealth Government announced the "Securing a Clean Energy Future – the Australian Government's Climate Change Plan". Whilst the announcement provides further details of the framework for a carbon pricing mechanism, uncertainties continue to exist on the impact of any carbon pricing mechanism on the Group as legislation must be voted on and passed by both houses of Parliament. In addition, as the Group will not fall within the "Top 500 Australian Polluters", the impact of the Carbon Scheme will be through indirect effects of increased prices on many production inputs and general business expenses as suppliers subject to the carbon pricing mechanism are likely to pass on their carbon price burden to their customers in the form of increased prices. Directors expect that this will not have an significant impact upon the operation costs within the business, and therefore will not have an impact upon the valuation of assets and/or going concern of the business.

NOTE 1: STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES (Cont'd)

(s) New Accounting Standards for Application in Future Periods

The AASB has issued new and amended accounting standards and interpretations that have mandatory application dates for future reporting periods. The Group has decided against early adoption of these standards. A discussion of those future requirements and their impact on the Group follows:

• AASB 9: Financial Instruments and AASB 2010-7: Amendments to Australian Accounting Standards arising from AASB 9 [AASB 1, 3, 4, 5, 7, 101, 102, 108, 112, 118, 120, 121, 127, 128, 131, 132, 136, 137, 139, 1023 & 1038 and Interpretations 2, 5, 10, 12, 19 & 127] (applicable for annual reporting periods commencing on or after 1 January 2013).

These standards are applicable retrospectively and amend the classification and measurement of financial assets. The Group has not yet determined the potential impact on the financial statements.

The changes made to accounting requirements include:

- simplifying the classifications of financial assets into those carried at amortised cost and those carried at fair value;
- simplifying the requirements for embedded derivatives;
- removing the tainting rules associated with held-to-maturity assets;
- removing the requirements to separate and fair value embedded derivatives for financial assets carried at amortised cost;
- allowing an irrevocable election on initial recognition to present gains and losses on investments in equity instruments that are not held for trading in other comprehensive income. Dividends in respect of these investments that are a return on investment can be recognised in profit or loss and there is no impairment or recycling on disposal of the instrument; and
- reclassifying financial assets where there is a change in an entity's business model as they are initially classified based on:
 - a. the objective of the entity's business model for managing the financial assets; and
 - b. the characteristics of the contractual cash flows.

AASB 10: Consolidated Financial Statements (applies to periods beginning on or after 1 January 2013)

This Standard establishes a new control model that applies to all entities. It replaces parts of AASB 127 Consolidated and Separate Financial Statements dealing with the accounting for consolidated financial statements and Interpretation 112 Consolidation – Special Purpose Entities.

The new control model broadens the situations when an entity is considered to be controlled by another entity and includes new guidance for applying the model to specific situations, including when acting as a manager may give control, the impact of potential voting rights and when holding less than a majority voting rights may give control. This Standard is not expected to impact the Group.

• AASB 13: Fair Value Measurement (applies to periods beginning on or after 1 January 2013)

This Standard establishes a single source of guidance under AASB for determining the fair value of assets and liabilities. AASB 13 does not change when an entity is required to use fair value, but rather, provides guidance on how to determine fair value under AASB when fair value is required or permitted by AASB. Application of this definition may result in different fair values being determined for the relevant assets.

AASB 13 also expands the disclosure requirements for all assets or liabilities carried at fair value. This includes information about the assumptions made and the qualitative impact of those assumptions on the fair value determined. The Group has not yet determined any potential impact on the financial statements.

Interpretation 20: Stripping Costs in the Production Phase of a Surface Mine (applicable for annual reporting periods commencing on or after 1 January 2013)

This interpretation applies to stripping costs incurred during the production phase of a surface mine. Production stripping costs are to be capitalised as part of an asset, if an entity can demonstrate that it is probable future economic benefits will be realised, the costs can be reliably measured and the entity can identify the component of an ore body for which access has been improved. This asset is to be called the "stripping activity asset".

The stripping activity asset shall be depreciated or amortised on a systematic basis, over the expected useful life of the identified component of the ore body that becomes more accessible as a result of the stripping activity. The units of production method shall be applied unless another method is more appropriate.

i. Interest rate risk


